(a) General Service Metered Rate

For use of and service rendered by the corporation based upon the use of water supplied by said corporation:

Next 30,000 gallons	\$5.37*
Next 60,000 gallons	\$4.66*
Over 100,000 gallons	\$4.23*

(b) Monthly Minimum Charge

Each member shall pay a monthly minimum charge in accordance with the following applicable size of meter installed, for which the member will be entitled to, and pay rates for the amount of water used set out in the above metered block rates, as well as water tracking adjustment found in Appendix A.

(c) Fire Protection Service

Service under these rates shall generally consist of stand-by service for emergencies and all water taken through such connections shall be restricted to fire emergencies unless other temporary use shall have been specifically authorized by the corporation.

Private hydrants shall be defined as all hydrants in which a municipality is not paying the annual municipal hydrant fee.

Each member who lives within a one thousand feet (1,000) of a hydrant shall pay the following per month: \$1.63

Each applicant for a private fire line connection shall pay a charge to cover the costs of: coordinating connections, specifications, inspection during tapping of the main, GPS operations, GIS As-Built drawings, labor for flushing the fire line, inspection of backflow protection devices, two (2) bacteriological samples and inspection of leak testing. In addition to this charge, will be the prevailing cost of all water used during filling, flushing, leaks and extra bacteriological samples. The Fire Line Connection Charge shall be: \$350.00

(d) Temporary Users

Water furnished to temporary users such as contractors shall be charged on the basis of the metered gallon rates hereinbefore set forth and the number of gallons shall be estimated and/or established by the water corporation with a rented hydrant meter.

(e) Connection Charge

1) Each applicant for a 5/8 x 3/4 inch meter shall pay a charge to cover the costs of: excavating and tapping the main, furnishing and installing service pipe from the main to the meter location, furnishing and installing corporation stops, and furnishing and installing meter pit (if outside), setter and meter reading equipment. The charge for a 5/8 x 3/4 inch meter tap shall be \$1,422.00.

2) Each applicant for a tap larger than a 5/8 x 3/4 inch meter shall pay the actual cost of labor, materials, power machinery, transportation and overhead incurred for installing the tap, but shall not be less than the charge of a 5/8 x 3/4 inch meter tap.

3) Added to the fees charged in Item 1 or 2 above shall be the actual cost of all state, city and county permits.

(f) Membership Fee \$150.00

A membership fee shall be paid in addition to the connection charge and start-up fee upon application for the membership in this corporation. The membership is refundable, less any final charges.

(g) Nonpayment Fee \$76.00

When a customer has not paid by the due date and time printed on their disconnect notice and a work order has been printed and technicians dispatched, this charge will be made by the Corporation regardless of whether the water service has been disconnected or not. If the service is disconnected, this charge, together with any arrears due, must be received before 4:00PM to restore service the same day. No turn-ons will be performed after hours.

(h) Reinstallation/ Lock Charge \$56.00

When a meter has been removed or locked following service disconnection due to tampering with or unauthorized use of the service and/or meter by a member, there shall be assessed a charge for the removal or locking and reinstallation of the meter. Any costs for materials needed for repairs will be in addition to this charge.

(i) General Service Charge \$55.00

This charge will be made for any trip to the member's premises at their request for conditions on the member's responsibility side of the meter during the period of 8:00 a.m. to 4:00 p.m. weekdays.

(j) General Service Surcharge \$10.00

This charge will be made in addition to the \$55.00 general service charge for such service on Saturday, Sunday, holidays, and before 8:00 a.m. or after 4:00 p.m. on weekdays.

(k) Collection and Deferred Payment Charges

All bills for water services not paid within seventeen (17) days from the due date thereof, as stated in such bills, shall be subject to the collection or deferred payment charge of ten percent (10%) on the first \$3.00 and three percent (3%) on the excess over \$3.00.

(l) Returned Check/ Drafting Charge \$25.00

This charge will be made for each instance that a check or bank drafting issued in payment is returned to the corporation by the depository bank, such check or drafting not having been honored by the bank for any reason.

(m) Postage Charge-Delinquent Accounts

At any time a delinquent billing for water services is required to be mailed, an additional charge of twenty-five cents (\$.25) shall be made for postage.

(n) Credit/ Debit Card Processing Fee \$2.50

A fee of \$2.50 shall be paid for each transaction in an increment range of \$200 to cover bank processing fees and administration of credit and/or debit card transactions. (example \$1-\$200 = \$2.50 fee, \$200.01-\$400 = \$5.00 fee, etc.)
Unless a third party processing company is used and member pays fees directly to them.

(o) Start-Up Fee (Non-Refundable) \$55.00

The Start-up Fee shall be paid in addition to the membership fee and / or connection charge, upon application for membership in this corporation and is non-refundable. New members shall pay this fee to cover the administration and maintenance costs associated with activating an account.

(p) Rates Applicable to All Users

The rates herein set out shall apply to all users and/or members, regardless of prior and existing contracts calling for different rates whether lower or higher.

Water Tracking Adjustment - The water tracking factor set forth in this schedule is applicable where clearly denoted on other rate schedules and shall be occasioned solely by changes in the wholesale cost of water, in accordance with 170 IAC 6-5-1.
